The new school will serve as the junior high for this area, catering to students in grades 6-9, while Park West is planned to become the elementary school.
- The next phase of work is to develop the details of the design where the SST will be consulted on the interior and exterior design, landscaping, recreational features, and community art project.

#### **Presentation Discussion:**

- "Triple gymnasium" is 3 learning spaces that are spread over one full gymnasium with a dividing wall and one half gymnasium.
- There was clarification that the Mainland Trail will not be affected by the construction of the new school.
- Field development is still to be determined. The current field is more
  of a green space. There were inquiries about the possibility of
  developing the field into a full field/soccer pitch. HRM has not
  scheduled the field for maintenance and significant work would need
  to occur for it to be brought to a full field standard.
- Spectator viewing into the gym was discussed. Parents and coaches enjoy opportunities to view sports like community basketball. There is space in the gym for spectators and bleachers on one side of the larger gymnasium. Currently bleachers are not included but may be considered if there is community support and funding.
- The double swinging doors leading to the classroom wings lock, which would keep people out of the educational areas when the gym is being used for community purposes.
- In other schools, the wall panels separating the double gym can be difficult to operate. A retractable wall might be a better consideration.

- This design concern is being discussed, with a double vinyl curtain being considered as an alternative option.
- There are 5 washrooms for each wing, which exceeds building code requirements. Universal washrooms will be constructed using concrete block, and not drywall. Within each washroom bank, there will be a mix of standard stalls and at least one accessible stall designed to meet barrier-free requirements. Each wing will include at least one universal washroom. All stalls will be fully enclosed for privacy. Sinks are currently planned to be located in an open alcove area visible from the corridor, with at least one barrier-free sink. . It was requested to add mirrors on the back of the stall doors for girls to adjust their hijabs. This request will be brought forward for further discussion and consideration.
- The windows in the breakout areas of the corridors are not floor to ceiling to allow cubbies and furniture to go underneath.
- The layout of the school can accommodate growth up to 1150 students, but is based on 950 students.
- The stage is off the cafeteria and not the gym. It is not counted as a learning/classroom space.
- Is there an opportunity for an exterior door on the cafeteria, which could be accessible by our vendors using the kitchen? Architects are meeting with their kitchen consultants and EECD's food program managers and will discuss this option.
- Can exterior seating be removable so it will not impede ground maintenance, such as snow removal? Yes, permanent fixed furniture in the cafeteria and courtyard will be removed from the design.
   Movable furniture can be incorporated with the FFE Team and would be procured as furniture located in the interior/vestibule area.
- There are concerns about after school access and vandalism occurring in the courtyard. A fence with a gate will be installed around the courtyard so that the general public cannot access the area outside of school hours.
- The basketball court located in the bus loop will be gated off from traffic when not in use by buses.
- There are concerns with ongoing broken windows on the back side of Park West and that the same thing might happen at the new school.

- Where the courtyard and backside of the school are very open, it is hoped this will mitigate the potential for vandalism.
- Substantial performance means the building is usable for its intended purpose, though minor work may remain.
- At the upcoming meetings, we will be looking for input to the school design, grounds/fields, opportunity for a community art project and the opportunity for community fundraising ideas for enhancements like bleachers and a scoreboard for the large gymnasium.
